

Release and Waiver of Liability, Assumption of Risk Agreement

I have voluntarily and knowingly chosen to utilize the beneficial services of Fox River State Bank (hereinafter, "Fox River"), including, but not limited to the provision of transportation to and from social events as well as the hosting and organizing of social events upon Fox River State Bank premises. The benefits provided to me by Fox River I recognize as gratuitous and further recognize as of value to myself, but with no corresponding obligation flowing from myself to Fox River State Bank. I understand that there are dangers and risks inherent in both my participation in and travel to and from various activities which Fox River may from time to time host and/or organize.

In consideration of being able to participate in these social and recreational activities hosted and organized by Fox River, **EACH OF THE UNDERSIGNED**, for myself, my personal representatives, heirs, and next of kin, **HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE OR BRING A CLAIM AGAINST FOX RIVER STATE BANK, ANY SUBSIDIARY OF THE SAME, ITS RESPECTIVE PARENT COMPANIES, AFFILIATES, DIRECTORS, OFFICERS, GOVERNORS, EMPLOYEES AND/OR AGENTS, AND ANY ALL PARTICIPANTS AND ORGANIZERS OF OTHER INTERESTED PARTIES (ALTOGETHER HEREINAFTER REFERRED TO AS "RELEASEES")**.

I assume full responsibility for the risk of personal injury, death, and property damage due to the negligence and/or fault of the parties released by this document, and/or due to the condition of the premises upon which any such related activities will take place, whether such negligence, fault and/or condition of the premises is present at the signing of this agreement or taking place in the future.

THE UNDERSIGNED RELEASES from any and all liability the Releasees for any and all loss or damage, and any claims for injury or death evolving out of any such related event, **WHETHER CAUSED BY RELEASEES NEGLIGENCE OR OTHERWISE**. The undersigned hereby agrees to this **RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AGREEMENT EXTENDS TO ALL ACTS OF NEGLIGENCE BY THE RELEASEES**; however, this agreement shall not waive liability for intentional or reckless acts committed by Releasees.

THE UNDERSIGNED HAS READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AGREEMENT AND FULLY UNDERSTANDS ITS TERMS, UNDERSTANDS THAT HE/SHE HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO HIM/HER AND DESIRES HIS/HER SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT OF THE LAW AS ALLOWED BY THE STATE OF WISCONSIN AND FURTHER AGREES THAT NO ORAL REPRESENTATIONS, STATEMENTS OR INDUCEMENTS APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE.
